

"ACCADEMIA APERTA" VISITS THE WORLD AND TRANSFORMS ITSELF INTO A DIGITAL EVENT

EQUITA AWARDED THE STUDENTS OF THE BRERA ACADEMY AT THE THIRD EDITION OF THE "PREMIO EQUITA PER BRERA" CEREMONY

Two years after the launch of the partnership to promote education and research on artistic disciplines, Equita – the leading independent investment bank in Italy – and Accademia di Belle Arti di Brera confirm their commitment to support students and young artists of the Milanese Academy.



This year the event "Accademia Aperta" – sponsored by Equita for the third year in a row –celebrates its sixth anniversary.
