Notice of change in share capital and new Company Bylaws

Milan, December 10th, 2025

EQUITA Group S.p.A. (the "Company") announces the filing to the Companies' Register of Milan – Monza Brianza – Lodi of its new Bylaws with the updated share capital. The change in share capital follows the issue of new ordinary shares deriving from the exercise of stock options from beneficiaries of the incentive plan "EQUITA Group Plan based on financial instruments 2019-2021" in the window period 1 December 2025 – 3 December 2025. Following the issue of new ordinary shares, on December 9th, 2025, the Company has also increased its share capital, pursuant to the Shareholders' Meeting resolution of April 29th, 2021.

The increase in share capital involved No. 16,500 newly-issued ordinary shares of the Company (equal to approximately 0.03% of the n. 51,229,269 total outstanding shares as of today – thus No. 52,753,026 shares, less No. 1,523,757 treasury shares)¹. The share capital was increased by a nominal amount of €3,754.40.
