Today, during the event held at Bocconi University "The Italian corporate bond market: what is happening to the capital structure of Italian non-financial companies?" and where the position paper that analyses the decisions of Italian non-financial corporates to appeal to the bond market instead of the traditional bank lending has been presented, Equita awarded, with the sponsorship of Bocconi University and Borsa Italiana, the "Awards for the best strategy on capital markets" for the following fund raising categories: debt capital markets, equity capital markets and small-mid caps companies in equity capital markets.

With this prize – reaching this year its sixth anniversary – Equita awards the companies that distinguished themselves in debt and equity fund raising during the year. The winners were selected among a set of transactions closed during the year, between the 1st January 2018 and the 31st December 2018.

Gaia Mazzalveri, Co-Head of the Investment Banking of Equita, presented the criteria involved in the selection process of the finalists' transactions and companies and awarded the winners highlighting: "The majority of the awarded companies turned to capital markets, in parallel with the traditional bank lending, to raise capital to sustain both their organic and external growth. This is a clear evidence that the Italian companies are aligning to their European competitors, historically more active on capital markets".
